## Pete DeBogory Celebrates 20 Years of Service



This year, General Manager Pete DeBogory celebrated his 20th year of service with the South Walton Utility Company, Inc. (SWUCI).

Within a year of being hired, Pete was promoted to General Manager as a result of his outstanding work. At that time, SWUCI serviced approximately 2,100 members with four coastal wells and 16 employees. Under Pete's strong leadership, today there are seven coastal wells, three wells at the well field, over 8,320 members, and 33 employees.

In 1989, Pete ensured that SWUCI was one of the first utilities ever to use the TouchRead Meter System- a groundbreaking technology that

significantly improved meter-reading speed and accuracy.

From the very beginning, Pete has played a key role in extending SWUCI and its services. He began by working to secure a long-term coastal water supply to South Walton County through the purchase of a piece of land now known as the Rock Hill well field. ### Base Rate Increase Effective October 2007

During the SWUCI Board meeting on March 20, 2007, the board approved the results of a rate study that showed a need for a base rate increase. As a result, the base rate for water and wastewater will increase slightly in October 2007. For example, the average bill for a person that uses 5,000 gallons per month will be approximately \$42.97 versus the current \$39.67. The increase only affects the base rate and does not affect the water usage rates.

# A Letter From the President



First, let me introduce myself as the new President of the Board of your South Walton Utility Company. I have been a member of the board for 11 years and have had the privilege of working with prior Presidents Gen. Bill Brown and Ken Creel. Their leadership has

been greatly appreciated by our Utility.

We have also been very fortunate to have a dedicated staff of employees, headed by Pete DeBogory, our General Manager. Pete observed his 20th year of service at a luncheon held on February 20th at our new maintenance facility with all employees attending. Pete's dedication to our organization and his service to South Walton are major contributions to our performance in meeting the community's needs.

We are also pleased to announce that Alicia Keeter has joined our staff as Project Manager. She is currently working on the Wellfield expansion project and on the addition of ground storage capacity at our Goldsby Road facilities. She attended Auburn University and is professionally trained in construction management.

In the near future, we face a major challenge in the need to expand the capacity of our wastewater treatment plant and to improve the quality of the reclaimed water that it produces. After extensive technical/economic studies of several alternatives by our consulting engineering firm, Baskerville-Donovan, we have opted


for an Advanced Wastewater Treatment process with a wetland discharge capability. The reclaimed water discharged from the plant will, for the most part, meet drinking water standards set by the Department of Environmental Protection. We are presently in the permitting stage of this project and hope to begin construction before the end of the year.

Our current cost estimate for the project is approximately \$22 million dollars. We expect to borrow approximately \$14 million from the State Revolving Fund loan program utilizing the Regional Utility Authority as a sponsor.

Needless to say, due to the financial burdens suggested by our upcoming required water and wastewater projects, along with increase of operating expenses, we are compelled to announce a rise in rates for our water and sewer services. In order to substantiate this increase, we funded a rate study conducted by a professional rate analysis organization.

Last, but certainly not least, we are proud to advise you that our Consumer Confidence Report of our water quality shows that our water continues to meet or exceed all state and federal standards. In fact, our water won a regional water taste test in March and we came in third in the state water taste test last month.

Thank you for giving me the opportunity to serve on your Board of Directors.

## Helpful Reminders

Some helpful reminders to help us serve you better during the summer months:

- ◆ **Please keep bushes and landscaping**, such as pine straw, away from your water meters. This allows SWUCI's meter readers and technicians to easily access them. Locating the meters can be difficult when they are covered by new growth and pine straw.
- ◆ When planning an out of town trip, **SWCUI recommends turning your water off at the valve in the meter box**. This will prevent unauthorized usage and could prevent damage should a line break in the house while you are away.
