## **Make Your Voice Heard**

South Walton Utility Company, Inc. (SWUCI) is a member-owned and operated utility that relies on a key group of volunteers to keep the company headed on the right track. As a member of SWUCI, you have the opportunity to help to decide who sits on the Board of Directors.

Members of the Board of Directors are elected to three-year terms. The current Board appoints a nominating committee to recommend candidates for upcoming vacancies. Individual members can also make Board nominations.

Backflow Preventers are vital to protecting our water system. Please make sure yours are tested annually by a certified backflow testing company and provide updated reports to our office.

## Water Conservation

SWUCI has a retro fit program in place. We will provide faucet aerators, showerheads and leak detection tablets to you at no charge. Ask at our office front desk for more information. Here are other ways you can help conserve water.

- Check for leaking toilet flappers
- Retrofit aging plumbing fixtures
- Adjust toilet fill valves to conserve water
- Encourage guests to conserve water while on vacation
- Use Xeriscape Landscaping and keep irrigation use to a minimum.
- Know where your meter shut off valve is located.
- Wash full loads of dishes and laundry to conserve water

## Rules for Nominations from the Membership

#### HOW TO NOMINATE A DIRECTOR

Any member of SWUCI can nominate a candidate for election to the Board of Directors by following these guidelines:

The individual(s) being nominated must be <u>an eligible member of</u> <u>SWUCI</u>.

•To be an <u>eligible member of SWUCI</u>, the individual must have an active account as of the nomination record date of <u>September 14, 2018</u>.

•Once elected to the Board of Directors, an individual can serve on the Board only so long as that individual remains an eligible member of the company.

You must prepare a petition nominating the individual of your choice on which you have presented sufficient information to validate that individual's status as an eligible member of SWUCI. A separate petition is required for each individual being nominated.

•The petition must include the signatures, addresses and account numbers of fifteen (15) eligible members of SWUCI **in addition to the individual being nominated** who are eligible as of the nomination record date of <u>September 14, 2018</u>.

You must provide a short (one page) biography of the individual being nominated which specifically sets forth the qualifications you feel this individual possesses which will make him/her an asset to SWUCI and its members by serving on the Board of Directors. Please keep in mind that this individual, if elected, will be expected to attend the monthly Board meetings, the Annual Member meetings and any special meetings as properly called.

All of this information must be delivered to SWUCI by mail or delivery to the Administrative Offices of SWUCI, 369 Miramar Beach Drive, Miramar Beach, FL 32550-4938.

This information must be received <u>no later than 4:30 p.m., on</u> <u>September 28, 2018.</u>

- This time frame is required to permit the individual's name and biography to be included on the printed ballot that will be mailed to all members.
- Petitions received after that date cannot be accepted and will not be considered.

# A Letter from the President

#### Greetings from your Water and Sewer Utility:



It's been both an honor and a challenge to serve as your board president this year, after the passing of Michael Flynt, our distinguished president these past five years. Those of you that knew Mike are probably aware that he not only proudly served his Country; but oversaw the business of South Walton Utility with fervent passion to assure the membership that the quality of the service received was always excellent. Before I move on with my comments, if you never knew or met Mike, you need to know some of his accomplishments in addition to his superb management of the Board at South Walton Utility. Mike had an illustrious career in the Air Force, receiving the Legion of Merit, the Distinguished Flying Cross and the Defense Meritorious Service Medal. Also, he was actively involved in local community af-

fairs, serving on Northwest Florida College Board of Trustees and President of the Senior Professionals at the College; and was a founder of the Choctawhatchee Basin Alliance; and a member of the Choctawhatchee Military Council and Air Commando Association. You can see Mike has set the bar very high, so following in Mike's footsteps is not only an honor, but a challenge to live up to the personal performance standards he has established in the Board President position at South Walton Utility.

2018 marks the 50th anniversary of South Walton Utility, Inc. In 1966 Col. Michael Grimaldi spearheaded the organization of prospective customers in Miramar Beach for the purpose of obtaining a community water and wastewater system. A not for profit certificate of Incorporation was filed on August 9, 1968, under chapter 617, Florida Statutes. The purpose of the Incorporation was to "own, construct, maintain and operate a water and wastewater system for the use and benefit of its members". We request all members to come and join us in our celebration of fifty years of service to you and the community at our Founder's Day Celebration.

Two notable projects in 2018 of several completed or in process were the relocation of utilities along Hwy 98 to support the highway widening through Miramar Beach and into Destin , and Well 13 was drilled and brought online in our designated field along Hwy 331 north of the Choctawhatchee Bay. This will assure that the members of South Walton Utility and Destin Water Users, based on growth forecasts and peak occupancy periods, will have a minimum of twenty years of continuous, quality water supply. Also, on an ongoing basis, Ms. Keeter has been evaluating the cost-effectiveness and efficiency of the South Walton Utility's overall operation and is committed to improving the bottom line to hold down future price increases to our membership.

When you turn on the tap. It's easy to see what your water bill buys. What's not as easy to see is what it takes to bring that water to your home. The miles of pipeline hidden below the ground.; the facilities that draw water from the wells; the plant where it is treated and tested. The technicians, engineers, and maintenance crews working around the clock to make sure the water is always there when you need it. Your water payments are helping to build a better tomorrow by supporting needed improvements that will keep quality water flowing for all of us – today and well into the future.
